I owed EZPass MA \$10,000 and no one told me!!! (self:boston)

I am at the end of my rope!

I am a Boston resident who owes \$4,600 in EZ Pass fines, which is now preventing me from being able to register my new car with the state (because if you owe outstanding fines you can't renew registration). I am a grad student and nonprofit worker: \$4,600 would bankrupt me and then some.

My fines, reduced from the original fine amounts of over \$9,000, weren't even my fault! Last October, my credit card account info. was changed and I was not notified. Again, my EZ Pass account information was changed without my knowledge, and EZ Pass/RMV have held me responsible for all charges accrued as a result. Although I was not notified that my account was in delinquent status via my online account, email or phone, I am now being held responsible for these exorbitant fees.

EZ pass sent 450 notification letters TO MY OLD ADDRESS, all of which were returned to EZ Pass violations processing center because I don't live there anymore (all other mail made it to me, somehow). In March, after 6 months, (and a horrible winter for me during which I lost my dad to cancer), the RMV withheld my registration and when I showed up at the RMV to figure out why, I was informed that I had 153 toll violations.

I went through appropriate channels to get a hearing; I did not receive a fair hearing. My hearing officiant, Laura, treated me as a criminal. She 1. did not allow me to submit "evidence" during my hearing 2. did not give me a written copy of her decision (even though my mother and I repeatedly asked for such) 3. Told me my only means of appeal was to pursue legal action (no mention of an appeals process whatsoever) and 4. informed me that she would only be able to keep my fines at the \$4,600 (reduced!) rate if I gave her written confirmation that I would not be pursuing further legal action in the case. (In other words, I gave her my word under duress). Now, I can't register my new car because of these fines, which are ABSOLUTELY ridiculous since they are a result of a computer error/my account being compromised. Each time I went through a toll, they slapped a \$90 charge on me. HELP!
